Chief of Armenia's General Department of Civil Aviation reports progress in ongoing reforms

During a working meeting held with the President of the Republic of Armenia, Head of General Department of Civil Aviation by the Government of the Republic of Armenia (GDCA) Sergey Avetisyan reported progress in the reforms being implemented in the sphere of aviation, development programs, existing problems and the measures aimed at their solution. Sergey Avetisyan dwelt on the results of international cooperation, the aviation infrastructure development programs, as well as on the steps aimed improving the airspace and the business environment for air carriers in the Republic of Armenia.

Detailing the results of cooperation with the European Union, the Eurasian Economic Union and a number of partner countries, the GDCA Head reported on the ongoing EU-Armenia talks over the common aviation zone, which kicked off in 2017, the Eurasian Economic Commission-approved roadmap of coordinated policy and the outcome of negotiations with 27 nations' aviation



authorities.

The President of the Republic of Armenia instructed him to consistently work with partners in order to strengthen and develop relationship in the aviation industry, providing the necessary conditions for the implementation of international flights.

The meeting discussed issues related to the expansion of Armenia's air connec-

tivity, the development of airports and air transport markets and the level of air training in the Republic of Armenia. In this connection, the President gave relevant instructions.

The GDCA Head presented an action plan in the above-stated directions, as well as the upcoming programs and expected results of cooperation with international aviation organizations.

Karabakh Leader sworn in for another term



Bako Sahakyan, Nagorno-Karabakh's president, was sworn in for another term on September 7 almost two months after local lawmakers voted to extend his decade-long rule.

Sahakyan, 57, was re-elected after serving two consecutive five-year terms. He was not allowed to stay in power longer before Karabakh enacted a new constitution in a referendum held in February. The new constitution calls for the Armenian-populated region's transition by 2020 to a fully presidential system of government which will lead to the abolition of the post of prime minister. The authorities in Stepanakert say this change will put Karabakh in a better position to cope with the unresolved conflict with Azerbaijan. Their opponents maintain, however that Sahakyan is simply keen to cling to power.

Sahakyan will continue governing Karabakh as an interim president until 2020. His candidacy for that post was backed in July by 28 of the 33 members of the Karabakh parliament representing three political parties allied to him.

Sahakyan pledged to implement democratic reforms, strengthen Karabakh's security and ensure continued economic growth of the local economy in his speech at an inauguration ceremony held in Stepanakert. "We are going to do everything to protect the honor and dignity of the Armenian people," he declared.

The Karabakh leader again did not clarify whether he will run in the next presidential election due in 2020.

Vitaly Balasanyan, the secretary of Karabakh's presidential Security Council, suggested in July that Sahakyan is unlikely to seek another re-election in 2020.

A retired army general, Balasanyan was the main opposition candidate in Karabakh's last presidential ballot held in 2012.

EU, Armenia share views on upcoming agreement and Common Assistance Framework


Prime Minister Karen Karapetyan received Head of EU Delegation to Armenia, Ambassador Piotr Świtalski. Issues related to Armenia's cooperation with the European Union, new EU-Armenia agreement were discussed at the meeting.

To begin with, the Prime Minister noted that regular meetings provide an opportunity to exchange ideas on bilateral cooperation agenda, speak openly and sincerely about various programs and activities.

"I want to reaffirm that in the face of its different structures, the European Union has always been and remains one of the most important partners on Armenia's foreign policy agenda," the Prime Minister emphasized.

Touching upon the current stage of the partnership, Ambassador Świtalski noted that they are preparing for a very serious event – the signing of a new EU-Armenia agreement – which will usher in a new era of cooperation. In this connection, he assured that everything will be done to achieve a new quality in all spheres of cooperation. According to the Ambassador, the Common Assistance Framework is very promising and will include new elements of cooperation.

"We greatly support your reform agen-



da. With the help of external experts, we have thoroughly analyzed your reform program. It is an ambitious program; now we are thinking about how to harmonize our efforts with your reform agenda. We wish to invest money where you think the reforms will be effective," he said.

The Armenian Prime Minister noted, in turn, that the European Union's cooperative stance and assistance programs add momentum to his government's reforms. "It is gratifying that your experts have analyzed my government's action plan and agreed that we are on the right path. I want to assure you that we know how to change the country as we are well aware

of our problems and shortcomings," the Prime Minister emphasized.

The parties noted that the work on the EU-Armenia Agreement and the Common Assistance Framework is proceeding normally and their views and approaches coincide. Both sides stressed the need for making the best possible choice of EU programs, ensuring transparency and stricter targeting in the implementation of all programs.

The interlocutors touched upon issues related to the agreement to be signed in the field of aviation, exchanged views on political development in the European Union.

Government moves to liberalize Armenian energy sector

The Armenian government approved on September 7 a package of draft legal amendments designed to liberalize the country's energy sector.

A government statement said they will help to attract new "suppliers" that will be able to engage in wholesale sales of electricity. It said the "liberal model" for regulating the sector will also "stimulate interstate trade" in electricity, suggesting that the new players will be able to import or export it to neighboring Georgia and Iran.

The statement added that the resulting introduction of "certain elements of competition" in the Armenian energy market will not only make the sector more efficient but also benefit consumers.

Prime Minister Karen Karapetyan's cabinet first announced plans for such a liberalization in July. "We have already presented a plan of actions which will ensure that the energy sector switches to a new, liberal model by 2021," Deputy Minister of Energy Infrastructures Hayk Harutiunyan said at the time.

The U.S. ambassador to Armenia, Richard Mills, declared

in June that U.S. energy firms could invest billions of dollars in the sector if the authorities in Yerevan open it up to competition and remove all obstacles to electricity exports to Georgia and Iran.

Harutiunyan said in that regard that senior officials from his ministry already hold "regular meetings" with Mills and U.S. businesspeople to explore possibilities of "expanding American companies activities in Armenia's energy sector."

Harutiunyan noted that one U.S. company, ContourGlobal, already privatized Armenia's largest hydroelectric complex two years ago in a \$250 million deal strongly backed by the U.S. government.

Russian natural gas and nuclear fuel currently generate at least 60 percent of Armenia's electricity. In addition, Russia's Gazprom monopoly owns the country's gas distribution network.

Karapetyan managed that network from 2001-2010. He held senior executive positions in Gazprom subsidiaries in Russia before being appointed as Armenia's prime minister in September 2016.

Armenia had never confirmed its participation in NATO drills in Georgia – Deputy DM

NATO has been and will always remain Armenia's partner, Armenian Deputy Defense Minister has said.

"We are a full member of the Collective Security Treaty Organization (CSTO), which is the main guarantor of our security," Deputy Defense Minister Artak Zakharyan told reporters on the sidelines of a conference in Yerevan.

He advised not to divide all other cooperation issues into "black and white" and added that "Armenia's military-political diplomacy fully complies with the country's foreign policy."

The comments come in the wake of the announcement by the Georgian side that Armenia had refused to participate in NATO drills that kicked off in Georgia on September 4.

To disperse the various speculations about the causes of the decision, Deputy DM Artak Zakaryan said "Armenia had never confirmed it would participate in the exercises."

"We initially plan our participation in this or that event, but the official confirmation comes close to the date of the event. Armenia had never confirmed its participation. Therefore, it



has not refused to participate," Zakharyan said.

He assured that "Armenia is losing nothing by not participating the drills."

The Deputy DM added that relevant departments of the Ministry of Defense are checking the sources of the Georgian side's information and will provide further comments, if necessary.

Religious leaders of Russia, Armenia, and Azerbaijan sign joint statement

On September 8, as a result of the trilateral meeting of the spiritual leaders of the region in Moscow, Russia; His Holiness Karekin II, Supreme Patriarch and Catholicos of All Armenians; His Holiness Kirill I, Patriarch of Moscow and All Russia; and Sheikh ul-Islam Allahshukur Pashazade, Grand Mufti of the Muslims of the Caucasus, made the following statement:

Today, we the spiritual leaders of Azerbaijani and Armenia, once again met in Moscow at the invitation of Patriarch Kirill of Moscow and All Russia, to discuss ways of a peaceful settlement of the Karabakh conflict,





without which it is impossible to achieve reconciliation and comprehensive security in the Caucasus. We attach a special significance to the consistent development of the peacekeeping dialogue, the continuation of the negotiations, and the international community's mediatory efforts which will help to achieve a comprehensive settlement of the conflict. We are convinced that disagreements can be overcome, relying on the moral values of kindness, love for thy neighbor, mutual forgiveness, and benevolence; propagated by the principles of good-neighborliness and traditional religions.

Artsakh Foreign Ministry document circulated in the UN



On August 23, the Ministry of Foreign Affairs of the Republic of Artsakh (Nagorno Karabakh Republic) circulated in the United Nations (UN) a document, presenting its position regarding the Azerbaijani policy of isolation against Artsakh. The document has been published on the UN official web-site.

The document states that the policy of Azerbaijan aimed at isolation of Artsakh is a blatant violation of the right to development enshrined

in the Charter of the United Nations, the Universal Declaration on Human Rights, the UN Covenant on Civil and Political Rights, and the UN Covenant on Economic, Social and Cultural Rights. The right to development is an inalienable human right that can be invoked both by individuals and peoples, and includes: full sovereignty over natural resources; self-determination; popular participation in development; equality of opportunity; the creation of favorable conditions for the enjoyment of other civil, political, economic, social and cultural rights.

By making a reference to a number of norms of international law, the document emphasizes that the realization of individual and collective human rights and fundamental freedoms, including economic and social rights, must not be dependent on the status of the territory where people live. Therefore, the lack of international recognition cannot affect the ability of a state to engage in international relations, including carrying out foreign economic activity.

The authorities of the Republic of Artsakh express readiness for co-operation with UN member states to ensure a stable and transparent framework for economic activity in the Republic.

The document concludes that: "The authorities of the Republic of Artsakh, for their part, are making every effort to ensure that everyone living in the Republic can equally enjoy all rights and freedoms, enshrined in fundamental international documents, to freely explore and realize his/her potential. By that the authorities of Artsakh contribute to the consolidation of a peaceful, stable and prosperous region of the South Caucasus".

Two Canadian MPs banned from Azerbaijan for visiting Nagorno Karabakh

Canadian MPs Tony Clement and Rachael Harder have been banned from Azerbaijan for visiting Nagorno Karabakh, the Globe and Mail reports.

Azerbaijan's foreign ministry has accused the MPs of falling for the "propaganda of the Armenian side" and ignoring four resolutions of the United Nations Security Council.

The Conservative MPs are visiting the region on a trip paid for by One Free World International, a Toronto non-profit group headed by a Muslim-turned-Christian that advocates for persecuted minorities.

Azerbaijan has lodged a protest with the Canadian government about the MPs' trip and placed them on its list of undesirable persons

In a telephone interview from Armenia's capital of Yerevan on Friday, Mr. Clement said he was taking part in a documentary that is being produced by One Free World.

"I am not here endorsing anyone. I want both sides to have a negotiated settlement of the situation but I am here on a fact-finding and humanitarian mission along with Rachael Harder," Mr. Clement said.

However, he conceded that he accepts Armenia's assertions that Azerbaijani forces have committed atrocities, citing beheadings and cutting off of the ears of Armenian soldiers.

"What I saw with my own eyes is very disturbing in terms of the atrocities that were committed by Azerbaijani forces. In terms of the political situation, I am sure I echo Global Affairs Canada when I say it is better to have a negotiated solution than a continuing war,"

Mr. Clement said.

A spokesperson for the Canadian Foreign Affairs Minister Chrystia Freeland did not directly criticize the two MPs, but made clear that the Canadian government does not wish to take sides in the territorial dispute.

"It should be noted that Canada recommends against all travel to the Nagorno-Karabakh region. We fully support the [Organization for Security and Co-operation in Europe's] efforts to forge a peaceful and comprehensive settlement between Armenia and Azerbaijan in the region," press secretary Adam Austen said. "A military solution is not the answer. This is a position we have communicated to the governments of both Armenia and Azerbaijan."

China to provide 10 million yuan in aid to Armenia

Armenian Defense Minister Vigen Sargsyan had a meeting with his Chinese counterpart Chang Wanquan.

The parties discussed a wide range of issues on bilateral and global agenda. They pointed to the training of military personnel and humanitarian cooperation as promising fields of collaboration.

Reference was made to issues of international security. China has been largely involved in resisting global challenges. 
The Defense Ministers of the two counties hailed the reciprocal support within the framework of international organizations.



At the end of the meeting the parties signed an agreement on the provision of a 10 million yuan aid to Armenia.

Armenian alcoholic beverages to flood the Chinese market

The Development Foundation of Armenia jointly with the Wine-growing and Winemaking Foundation of Armenia will promote the recognisability of the locally produced wines and cognacs: an agreement of cooperation was signed today by the heads of the Foundations Armen Avak Avakian and Zaruhi Muradyan.

As the first practical step, the Foundations will jointly organize the participation of Armenian companies in the Prowine China 2017 Exhibition to be held in Shanghai, China, from 14 to 16 November.

Prowine China is one of the largest international exhibitions of the sphere: 650 companies from 37 countries will attend the Exhibition; moreover, more than 12000 importers, distributors and wholesale buyers are envisaged to take part in it.

Fifteen wine, cognac and alcoholic drinks producers will represent the industry of Armenian alcoholic beverages with the joint pavilion at the Prowine China 2017. The participation of the Armenian companies will be co-financed within the framework of state support.

The Armenian beverages have already been exported to the Netherlands, Belgium, England, Germany and other countries under the contracts concluded with the support of DFA during the previous international wine exhibitions. Last year, with the support of the Wine-growing and Winemaking Foundation of Armenia, the Armenian wine-making companies took part in the MUNDUS VINI 20th Grand International Wine Awards international ceremony, returning with 10 gold and 13 silver medals and reaching new export markets.

FMD KL Europe to establish biotechnological park in Armenia

FMD KL Europe – the Armenian branch of FMD K&L International Corporation – has announced plans to establish a biotechnological park in Armenia.

The company is currently making investments in order to equip the organization with devices and equipment meeting international standards.

"We are opening a new biotechnological park in Armenia that will enable the company to increase the number of its employees to 250 and to contribute to the development of the sphere," head of the company Kirit Velani said at a meeting with Armen Avak Avakian, CEO of the Development Foundation of Armenia.

"Our next step is aimed at establishing the basis of clinical research in Armenia, and we are planning to open our first clinic in 2018




that will start from the research of care products of first necessity, such as shampoos and creams, to the complex clinical trials. The Development Foundation of Armenia and the Armenian government have been very supportive to us since the beginning of our activities," Kirit Velani noted.

Kirit Velani presented the potential of biotechnological sphere, noting that it is at the stage of industrial development and can become the driving force of the Armenian economy. "Two people, sitting in the Armenian lab, can create a material that can generate billions of revenue for the country", Velani said.

The interlocutors discussed the possible steps the government can take to develop the sphere of biotechnology.

"The main function of DFA is to facilitate the smooth operation of foreign companies and investors in our economy. Our job is to expedite all the procedures these investors and companies encounter in the state system, related to the customs, taxation, or communication, enabling the businesses to generate revenue and, hopefully, to reinvest it in our country", Development Foundation of Armenia CEO noted.

Theresa May challenged over Azerbaijani money-laundering scheme



Theresa May is facing calls to order an investigation into how UK companies were allowed to operate a £2.2bn lobbying and money-laundering scheme on behalf of Azerbaijan's ruling elite, The Guardian reports.

Opposition politicians urged the government to open an inquiry after the publishing of leaked information showing the Azerbaijani leadership made covert payments from 2012 to 2014 through a network of opaque British companies.

Some of this money went to politicians and journalists as part of an international lobbying operation to deflect criticism of Azerbaijan's president, Ilham Aliyev, and to promote a positive image of his oil-rich country. There is no suggestion that all the recipients were aware of the original source of the money. It arrived via a disguised route.

Tim Farron, the former Liberal Democrat leader, led calls for an inquiry, saying this was what happens "when the corporate landscape is too lightly regulated".

"Thanks to the Guardian investigation we learn of something called the Azerbaijani Laundromat," he said. "But now is the time to wash some fairly dirty laundry in public and find out exactly who paid money to whom and why.

"We need a full investigation to see

that dirty money has not been used to buy influence in the UK. The Azerbaijani government is guilty of systematic human rights abuses and it would appear the regime has been making payments on an industrial scale."

Margaret Hodge, the chair of the all-party parliamentary group for responsible tax who uncovered the use of tax havens as chair of the public accounts committee, added to calls for more transparency about the scandal.

Peter Dowd, Labour's shadow chief secretary to the Treasury, said: "Money laundering hurts our economy, steals from others and corrupts our society. The financial system should effectively and efficiently provide investment that benefits the whole economy, not boost the offshore bank balances of plutocrats and criminals here and abroad.

"We have seen too many of these shocking scandals in recent years because the Tories are incapable of taking on the rigged system, which hurts the many to support the very few."

"It's time Britain had a Labour Government that, with our Tax Transparency and Enforcement Programme, is serious about challenging these people and institutions that are taking us all for a ride."

Molly Scott Cato, a Green MEP who sits on the European parliament's eco-

nomics and monetary affairs committee and inquiry into the Panama Papers, said the revelations were shocking and reveal "once again that British claims to be a leader in transparency conceal a far grubbier reality".

"The relationship between UK companies and our murky offshore tax havens permit the world's corrupt elite to indulge their extravagant lifestyles at public expense," she said. "They then use these ill-gotten gains to buy political influence that prevents them from being held to account for human rights abuses and bad government."

The four firms at the centre of the Azerbaijani Laundromat were all limited partnerships registered in the UK. They were: Metastar Invest, based at a service address in Birmingham; Hilux Services and Polux Management, set up in Glasgow; and LCM Alliance, from Potters Bar, Hertfordshire. Their corporate "partners" are anonymous tax haven entities based in the British Virgin Islands, Seychelles and Belize.

Some of the cash from the £2.2bn fund was used to pay for luxuries such as cars, school fees, interior design and dentistry, while other sums went to European politicians and prominent figures linked to promotion of Azerbaijan.

Azerbaijan's ruling family is not directly named in the leaked documents. But the Guardian investigation found evidence of a connection was overwhelming. Large sums came via the state-owned International Bank of Azerbaijan, which is the largest bank in an oil-wealthy country, and yet earlier this summer it filed for bankruptcy protection in New York. The defence and emergency situations ministries in Baku all contributed cash.

The scheme was used to pay for the government's incidental expenses including the medical bills of Yaqub Eyyubov, Azerbaijan's first deputy prime minister. There were separate payments to Eyyubov's son Emin, Azerbaijan's EU ambassador, and to the president's press secretary, Azer Gasimov.

New documentary links 1915 Genocide to recent Azeri massacres of Armenians

A new Armenian Genocide documentary will be screened in many theaters across the United States and also available "on demand" as of October 7. Unlike other documentaries on the topic, this one is different and more relevant to today's non-Armenian viewers. The documentary titled, "Architects of Denial," and sub-titled "Genocide denied is genocide continued," links the mass killings of Armenians by the Ottoman Empire in 1915 to contemporary massacres of Armenians by Azeris, ethnic kins of Turks, in various cities of Azerbaijan, and threaten to kill Armenians living in the enclave of Nagorno-Karabakh (Artsakh).

The documentary is produced by two Hollywood celebrities, Dean Cain and Montel Williams. It interviews world famous personalities and experts on the Armenian Genocide, some of them for the first time, such as Julian Assange (WikiLeaks), FBI whistleblower Sibel Edmonds, prominent international lawyer Geoffrey Robertson, Prof. Taner Akcam, one of the first Turkish scholar to acknowledge the Armenian Genocide, Dr. Gregory Stanton, President of Genocide Watch, Armenia's President Serzh Sargsyan, Tom de Wall, an expert on the Caucasus region, Former U.S. Ambassador to Armenia John Evans, Cong. Adam Schiff, former Kurdish mayor of Sur, Diyarbakir in Turkey, Abdullah Demirbas, His Holiness Catholicos Karekin II, Bako Sahakyan, President of Artsakh, Prof. Ugur Ungor, an expert on the Armenian Genocide, Baroness Caroline Cox, a member of the UK House of Lords, eyewitness accounts of survivors of both the 1915 Armenian Genocide and the massacres in Baku and Sumgait, Azerbaijan, since 1988, and earlier in the 20th century, and this writer.

The interviews were conducted in several countries, including the United States, United Kingdom, Armenia, Artsakh, Azerbaijan, Turkey, and Russia by camera crews sent to these places at major expense and great risk. The documentary also weaves the commonality of various genocides from Cambodia to Sudan (Darfur), the Holocaust, the Bosnian and Rwandan genocides.

Here are important excerpts from statements made by some of those interviewed by the documentary-makers:

Julian Assange: "Turkey has gone all around the world aggressively lobbying diplomatically to make sure there are no references to the Armenian Genocide, including even the major powers such as the United States."

Pres. Serzh Sargsyan: "The leaders of Turkey and Azerbaijan announce from time to time that they are one nation, but live in different countries. And naturally along with that one nation, they are injecting the ideology of denial."

Perhaps the most scandalous revelation in the documentary was made by Sibel Edmonds who was fired from her FBI job for informing her superiors about the involvement of high-ranking U.S. politicians in illegal Turkish schemes: "The justification to the excuse the United States government has been using, we are doing this [denial of the Armenian Genocide] for sensitive diplomatic relations. This is a hypocrisy that I have been witnessing, especially with inside knowledge of what takes place in the United States. It started with trying to do the right thing and we fought criminal activities bought and abused and basic retaliation for that."

Explaining why Speaker of the House Dennis Hastert killed the genocide recognition bill at the last minute, Sibel Edmonds stated: "It was a move that came with a price. He had bribery with cash to lock this vote. He also took bribery in the form of sexual favors during his junket trips to Turkey in a particular hotel that he would stay. Sexual favors would be delivered to him – under-age males. Also it was delivered in his townhouse; it was bribery, foreign bribery which constituted

treason. But that was a very small portion of what the FBI has already gathered. In Chicago, he also was directly involved with the notorious Turkish network that handled very large percentage of heroin-related activities, operations, sales in the United States, including receiving cash in suitcases from these particular people, and he and his Chief of Staff; their evidences were monitored. They were bugged not only for audio, but also for video. The FBI had in its possession, starting from 1997 slam dunk evidence in their hands, criminally implicated Dennis Hastert. The State Dept. knows, many people in Congress whom I testified to, they know. And I said, 'you watch, there would be no accountability and mockery of the entire system.""

The documentary also shows an original footage in which Azeri soldiers barbarically cut off the heads and ears of Armenian soldiers and civilians during Azerbaijan's attack on Artsakh during April 2016!

Finally, the documentary-makers question several members of Congress who refuse to answer whether they believe the Armenian Genocide actually took place, except Congresswoman Eddie Bernice Johnson (Dem.-Texas) who is shown giving a speech at an Azeri energy conference, where she boasts:" I am a member of the [congressional] Azerbaijan Caucus, enthusiastic member, and supportive member!"

The documentary-makers then ask Cong. Johnson on camera: "do you deny that the Armenian Genocide happened?" She shamelessly answers: "I do deny that!" This is a major scandal for a serving member of Congress to make such a categorical denial which is rarely denied by Members of Congress. The Armenian-American community nationwide and their friends should support her opponent in the next election and those in her district should vote against her to remove her from Congress. Once one of these denialist scoundrels is kicked out of office, other members of Congress will be very careful not to deny the Armenian Genocide. We need to make an example of her!

Transparency International calls for investigation into Azerbaijani money laundering case



Transparency International, the global anti-corruption organisation, is calling for politicians, banks and businesses that helped to launder the reputation of Azerbaijan across Europe to be investigated and, if appropriate, for the perpetrators to be sanctioned.

The anti-corruption organisation will launch national and international advocacy campaigns targeted at strengthening anti-money laundering practices, identifying individual wrong-doing and calling for international organisations, including the Council of Europe, to investigate allegations of inappropriate behaviour and take corrective action.

This follows an investigation carried out by journalists in six countries (Czech Republic, Denmark, France, Germany, United King-

dom and United States) into a shady financial network that appears to have funnelled money from a US\$2.9 billion Azeri slush fund to pay decision-makers and prominent individuals across Europe.

"It is shocking to see that some politicians at respected bodies like the Parliamentary Assembly of the Council of Europe are up for sale and are willing to turn a blind eye to corruption and human rights abuses for cash. They must be sanctioned and we will put pressure on the authorities to take action. The story does not end here," said José Ugaz, Chair of Transparency International.

The investigation names, Danske Bank, a prominent bank in Denmark and specifically its branch in Estonia as the centre of the financial network. It also identifies four

shell companies set up in the UK with secret offshore owners that received money from the slush fund. In addition, individuals and businesses are reported to have received payments from these companies in Germany and the UK.

The reports describe how politicians and consultants who received the money were in a position to influence decisions about Azerbaijan's human rights record at the Parliamentary Assembly of the Council of Europe (PACE). The purpose of the payments appears to have been to limit the effects of damaging information regarding human rights and election fraud that would have brought the country into greater disrepute.

"These investigations show that even in countries where corruption risks are considered low like Denmark, which ranks at the top of Transparency International's Corruption Perceptions Index, the regulatory bodies are still behind in enforce anti-money laundering legislation," added Ugaz.

Transparency International, as part of a partnership with the Organised Crime and Corruption Reporting Project that broke the story, will pressure the appropriate authorities to ensure that any wrongdoing is both investigated and punished, and that regulatory loopholes are closed.

Taner Akçam to receive 2018 'Upstander' honor from World Without Genocide



Clark University history Professor Taner Akçam will be honored with the 2018 Outstanding Upstander Award from the World Without Genocide organization for his tireless work promoting justice and the rule of law, the Armenian Weekly reports.

World Without Genocide, housed at the Mitchell Hamline School of Law in St. Paul, Minn., works "to protect innocent people around the world; prevent genocide by combating racism and prejudice; advocate for the prosecution of perpetrators; and remember those whose lives and cultures have been destroyed by violence."

Akçam, one of the first Turkish intellectuals to acknowledge and

openly discuss the Armenian Genocide, holds the only endowed chair dedicated to research and teaching on this subject. As Robert Aram and Marianne Kaloosdian and Stephen and Marian Mugar Professor of Armenian Genocide Studies at the Strassler Center for Holocaust and Genocide Studies at Clark, he is committed to research, teaching and training future scholars. An outspoken advocate of democracy and free expression since his student days at Middle East Technical University in Ankara, he is an internationally recognized human rights activist.

"We have long admired your bold and dedicated work to document the atrocities perpetrated by the Ottoman government against the Armenian people. You have persisted in speaking out about the genocide, despite being marked for death by Turkish ultra-nationalists," Ellen J. Kennedy, executive director of World Without Genocide, wrote to Akçam.

Previous recipients of the World Without Genocide award include Eli Rosenbaum, director of human rights enforcement strategy and policy at the U.S. Department of Justice; Claudia Paz y Paz, former attorney general of Guatemala; and Magistrate Judge Peggy Kuo, former prosecutor at the United Nations International Criminal Tribunal for former Yugoslavia.

Akçam will formally receive the award at the organization's annual gala in May 2018 in Minneapolis.

House approves funding for Artsakh de-mining

The U.S. House today adopted an amendment by Rep. David Valadao (R-CA) backing continued Congressional appropriations for the HALO Trust's life-saving de-mining across the interior farmlands and villages of the Artsakh Republic.

The decisive move was welcomed by the Armenian National Committee of America (ANCA), which spearheaded the launch of Artsakh aid in the 1990s and has, over the past two decades, secured tens of millions of dollars in life-saving U.S. assistance to the independent republic.

The Valadao Amendment was approved by voice vote, as part of the FY 2018 foreign aid appropriation, which, in turn, is part of a broader spending measure (H.R. 3354), which will be voted on as early as Friday, September 8th. Congressman David Valadao (R-CA), who serves as a Co-Chair of the Congressional Armenian Caucus, was joined in supporting this bipartisan measure by House Foreign Affairs Committee Chairman Ed Royce (R-CA), House Intelligence Committee Ranking Democrat Adam Schiff (D-CA), and his fellow Armenian Caucus Co-Chairs Frank Pallone (D-NJ) and Jackie Speier (D-CA). Rep.

Valadao introduced his measure on the House floor, as part of an en bloc series of amendments, and spoke passionately in support of its adoption.

"Progress for Artsakh. The Valadao Amendment's overwhelming adoption by the full U.S. House of Representatives powerfully affirms, over Aliyev's relentless opposition, America's enduring support for Artsakh's safety and security," said ANCA Chairman Raffi Hamparian.

"We join with friends from Fresno, across America, and from as far away as Artsakh in thanking Congressman Valadao and all his colleagues for his leadership in the victory of this pro-peace, life-saving legislation."

Immediately following his amendment's passage, Rep. Valadao shared with the ANCA that: "It is a grave reality that families in Nagorno Karabakh live under the very real threat of landmine accidents each and every day. However, with the funding secured in my amendment today, I am optimistic significant strides will be made to ensure the region is landmine free by 2020, restoring these communities so they may live without fear of mine-related accidents."

Rep. Pallone concurred, noting that "I was proud to work with my colleagues to extend aid to Nagorno Karabakh. U.S. aid especially towards demining efforts in Nagorno Karabakh has helped the HALO Trust to clear mines, cluster munitions, and other explosive remnants of war since 2000. This aid will help HALO Trust to complete this important work by their 2020 deadline and I will continue to work to support efforts relating to Nagorno Karabakh in the future."

Rep. Speier thanked her colleagues for "providing critically needed funding for the ongoing effort to remove deadly landmines from Artsakh. Given the danger posed to the people of this Republic – an area that suffers the highest per capita incidence of landmine accidents in the world, with a third of these casualties involving children – this modest \$1.5 million amendment is destined to have a major impact on the physical and mental health of the people of Artsakh. It also shows our government's strong and abiding commitment to securing peace and prosperity for Artsakh, which has achieved great progress and has an even brighter future on its horizon."

The Valadao Amendment represents the first time in four years that the full U.S. House has gone on record affirming its official support for the Artsakh assistance program. The Senate has traditionally been more consistent in its support in this area. The Executive Branch is responsive to Congressional intent, as reflected in legislative and report language, particularly on appropriation priorities.

Thanks to the efforts of the ANCA and the leadership of Senator Patrick Leahy (D-VT), former Senator Mark Kirk (R-IL), Congressional Armenian Caucus Co-Chair Frank Pallone and former Republican Co-Chair Joe Knollenberg (R-MI) and many others - the U.S. has provided millions in funding to The HALO Trust, which has successfully demined approximately 97% of Artsakh. Over the last 16 years, the HALO Trust has destroyed over 8,733 anti-personnel mines, 2,584 anti-tank landmines, 180,858 small arms ammunition, 12,423 cluster bombs and 48,572 other explosive items

The ANCA's efforts to secure direct U.S. assistance to Artsakh date back to May of 1997, when Congressman Brad Sherman first offered an authorization amendment, as a member of the House Foreign Affairs Committee, to the Foreign Policy Reform Act, to authorize direct U.S. funding for Artsakh. This effort lead to subsequent support, later that same year, by appropriators, notably then-senior Congressman Joe Knollenberg of Michigan, who successfully worked to ensure that the House Appropriations Committee approved a Foreign Aid bill (Public Law 105-118) that ultimately led to the allocation of an initial \$12 million FY 1998 allocation for Artsakh.

Mossessian Architecture plans two buildings in London clad in tuff stone from Armenia

Mossessian Architecture – an award-winning London-based architecture practice – has lodged plans for another new office building in King's Cross, central London, the Architects' Journal reports.

The proposals include a 26,172m², eleven-storey office block – called S1 – on the corner of Handyside Street and Canal Reach, with a roof terrace as well as restaurants and shops at ground level.

Backed by Argent, the new proposal accompanies another office scheme by Mossessian Architecture known as S2 which is on site nearby and is set to complete in Autumn 2018. That block has already been pre-let to DeepMind Technologies, a Google-owned artificial intelligence company.

Both buildings will be clad in tuff stone – a black volcanic lava stone from Armenia.

London-based French-Armenian architect Michel Mossessian, founder of Mossessian Architecture said: 'King's Cross is one of today's templates for urban placemaking, so our priority was to develop spaces that both convey a strong identity and continuum with the public realm.

'The key is to acknowledge that there is a fine line between public spaces and tenants' private realms, from the ground up to the rooftops of the buildings. This second building works to engage the space between the two, making the spaces hang together and generating a strong and engaging urban and spatial character for both the eventual tenant and the visiting public.'

Subject to planning approval, S1 is expected to start on site in December this year.

S1 is located on the corner of Handyside Street and Canal Reach. Both buildings will be clad in tuff stone, black volcanic lava stone from Armenia, a first for buildings of this scale in the UK.

Sitting next to each other, buildings S1 and S2 respond to each other to form an urban piece where the mass of the buildings and void created between them relate to the urban flow









and place making. The space in-between forms a dramatic sculptural void and acts as a passageway leading to a new public square – Keskedee Square – that will offer a variety of restaurants, retail spaces and meeting places.

S1 completes the architectural language of its sister building, offering the same black stone as mass with natural anodized window frames sequenced in rhythmic modulation, in contrast with a variegated textured glass defining the public realm.

The building consists of eleven floors of office space – NIA from 1,124 to 2,145 m2 – with restaurants and retail units at ground level. Three levels are equipped with large terraces, and the eleventh floor has a generous landscaped roof terrace accessible to all tenants.



As a result of the tight cooperation with Saint Petersburg tourism development committee within the last three years an effective working program was worked out within the frames of which social advertising exchange was carried out, joint mutual visits were organized. However all this is not enough and we set new tasks before us. In particular, the time has come to start active cooperation between tourism information centers of the two cities", said Maria Baraghamyan.

During the meeting Gevorg Orbelyan presented the tourism potential of Yerevan inviting the participants of the round table to visit Yerevan next year to take part in the celebration of the 2800th anniversary of the capital of Armenia.


