## EU, Armenia explore closer ties

Armenian Foreign Minister Ararat Mirzoyan had a meeting with EU High Representative for Foreign Affairs and Security Policy Josep Borrell on the sidelines of the OSCE Ministerial Council in Skopje.

Issues of expansion of the Armenia-EU partnership agenda were discussed at the meeting. Ararat Mirzoyan and Josep Borrell thoroughly reflected on the existing perspectives and efforts in that direction, in favor of closer Armenia-EU rapprochement and ensuring tangible results for the citizens.

Reference was made to the effective discussions held recently in Yerevan and Brussels with the participation of representatives of the EU and its member states, the readiness of the parties to implement the ambitious Armenia-EU agenda was emphasized.

In a follow-up to the meeting held in Granada in October, the Minister of Foreign Affairs of Armenia and the High Representative of the EU Council of Ministers of Foreign Affairs discussed issues of security in the South Caucasus.

Ararat Mirzoyan emphasized the importance of diplomatic efforts aimed at restraining any ambitions towards the territorial integrity and sovereignty of Armenia, implementing regional inclusive programs and establishing lasting stability.

In this context, Minister Mirzoyan also presented the "Crossroads of Peace" program developed by the Armenian government.

Reference was made to the steps taken to address the needs and rights of more than 100,000 people of Nagorno Karabakh, including through the involvement of international partners.

## Blinken reaffirms United States' ongoing support for Armenia's sovereignty and territorial integrity

Armenian Prime Minister Nikol Pashinyan has spoken by phone with U.S. Secretary of State Antony Blinken.

Secretary Blinken reaffirmed U.S. support for Armenia's sovereignty and territorial integrity, the U.S. State Department said in a readout of the November 27 call.

"Secretary of State Antony J. Blinken spoke today with Armenia's Prime Minister, Nikol Pashinyan. They discussed U.S. support for efforts to reach a durable and dignified peace agreement between Armenia and Azerbaijan. The Secretary reaffirmed the United States' ongoing support for Armenia's sovereignty and territorial

integrity, and outlined efforts to increase bilateral cooperation with Armenia as we work to support its vision for a prosperous and democratic future," the U.S. State Department said.

Blinken also spoke by phone with Azerbaijani President Ilham Aliyev on the same day.

In a readout of the call with Aliyev, the State Department said that Blinken noted "recent points of concern" in the U.S.-Azeri relations.

"The Secretary welcomed President Aliyev's commitment to conclude a durable

and dignified peace agreement between Azerbaijan and Armenia. The Secretary recognized the suffering that this long-standing conflict has caused Azerbaijanis and Armenians alike and underscored the benefits that peace would bring to everyone in the region. The Secretary discussed our enduring relations with Azerbaijan, noted recent points of concern in the relationship and also spoke about opportunities to strengthen cooperation, especially around the peace process, and the importance of high-level engagement," the State Department said.

## First session of the Armenia-UN Joint Steering Committee held in the Government

The Government of the Republic of Armenia and the UN Office in Armenia have officially announced the commencement of the Joint Steering Committee. This committee serves as a key pillar in the implementation of the 2021-2025 UN Sustainable Development Cooperation Framework for Armenia.

During the session, the Joint Steering Committee discussed the Republic of Armenia's progress in implementing the UN Sustainable Development Goals and addressed challenges, including the massive influx of forcibly displaced refugees from Nagorno-Karabakh, Grigoryan's Office said in a statement.

The Committee emphasized the importance of comprehensively addressing the humanitarian and development needs of refugees, ensuring their sustainable development.

Additionally, the committee stressed the need to outline further measures for

the implementation of the UN SDGs, considering the current socio-economic, humanitarian, and security situation in the country."

According to the source, Armenian Deputy Prime Minister Mher Grigoryan said in the opening speech: 'Armenia, committed to the implementation of the 2030 agenda, continues to make efforts towards achieving the goals of sustainable development. A vivid proof of that commitment is the ambitious agenda of reforms implemented by the Government, which is based on a people-centered, inclusive approach and the protection of human rights.

On the path of sustainable development and strengthening of democracy, the United Nations Organization has been and remains one of our most important partners, which has always been a supporter of socio-economic progress in Armenia, the introduction of a good governance

system, and a number of other activities."

It is noted that during the inaugural session, Acting UN Resident Coordinator in Armenia Nanna Skau stated: "The launch of the Joint Steering Committee is of great importance for the existing partnership between the Republic of Armenia and the United Nations.

In the conditions of open dialogue, the Armenian government and the United Nations share a common vision for the development of the country. It is through this dialogue that we aim to empower people, build capacity, and create an enabling environment."

It was emphasized that with a commitment to cooperation, inclusiveness and accountability, the meetings of the Steering Committee will be held at least once a year, strengthening the basis of a stable and developing partnership between the Government of Armenia and the United Nations.

## Armenian Prime Minister and South Korean President discuss bilateral agenda

Armenian Prime Minister Nikol Pashinyan has spoken by phone with South Korean President Yoon Suk Yeol.

According to a readout issued by the Prime Minister's Office, the two leaders "were pleased to highlight the recent

intensification observed in bilateral relations, as a result of which an agreement has been reached on opening embassies in the two capitals on the basis of reciprocity."

A number of issues of bilateral interest

were also discussed.

PM Pashinyan and President Yoon Suk Yeol expressed readiness to contribute to the development of bilateral relations between Armenia and South Korea.





## EU and Armenia look into strengthening and deepening their partnership

From 27-29 November, a delegation of the European External Action Service and the European Commission visited Armenia to explore possibilities to deepen and strengthen EU-Armenia relations in all dimensions including under the EU-Armenia Comprehensive and Enhanced Partnership Agreement.

The EU and Armenia are committed to building a partnership delivering tangible benefits to the citizens. The participants discussed

ways to further strengthen cooperation and delivery of reforms inter alia in the areas of energy, transport, digital, research & innovation, including through investments. They exchanged on how to best leverage investments to address the immediate needs and enable integration of displaced Karabakh Armenians, as well as to strengthen Armenia's economic and social resilience in the longer term.

Both the EU and Armenian side expressed an interest to continue the cooperation on justice and police reform; to strengthen collaboration on migration and mobility; and to explore options to possibly launch a visa liberalization dialogue with Armenia. It was also agreed to explore areas to strengthen cooperation between the EU's Border and Coast



Guard Agency (Frontex) and Armenia. The meetings further confirmed the mutual interest of Armenia and the EU to further the dialogue and cooperation in the areas of security and defense. The EU will for instance further explore non-lethal support to the Armenian military via the European Peace Facility.

At the occasion of the visit, the EU and Armenia also inaugurated the EU-Armenia Investment Coordination Platform. This platform brings together the EU, the government of Armenia and International Financial Institutions, and it will help further step up EU investments in Armenia under the Economic and Investment Plan, which has already mobilized close to EUR 500 million in Armenia. Two new projects were signed during this first

ever meeting of the Platform, aimed at improving energy efficiency in kindergartens in cooperation with the European Investment Bank (EIB) and providing support to Armenian SMEs in cooperation with the European Bank for Reconstruction and Development

The EU reiterated its continued support to the normalization of relations between Armenia and Azerbaijan based on the principles of mutual recognition of territorial integrity and

inviolability of borders based on the 1991 Almaty Declaration. Following the discussions of the Foreign Affairs Council on 13 November, the EU will also reinforce the EU Mission in Armenia.

Along the EEAS and the European Commission, representatives of the European Bank for Reconstruction and Development (EBRD), the European Investment Bank (EIB) and Frontex joined the visit.

The delegation met with Deputy Prime Minister Mr Mher Grigoryan, Deputy Prime Minister Tigran Khachatryan, Deputy Foreign Minister Mr Paruyr Hovhannisyan and with the relevant Deputy Ministers. They also exchanged with the civil society organizations and representatives of the UN agencies present on the ground.

## Azerbaijan delays peace talks with Armenia for unclear reasons, warns Armenian Speaker of Parliament

Azerbaijan has been delaying peace talks with Armenia for unclear reasons, Speaker of Parliament of Armenia Alen Simonyan has said.

Speaking to reporters on November 28, Simonyan said that Azerbaijan has been avoiding a number of different formats of the talks.

"I don't understand why Azerbaijan has been avoiding various formats. First, they accused France, then they accused Brussels, they rejected some format, and then they rejected the Washington format. I honestly don't understand what this

kind of delay would give Azerbaijan and the region, when they are speaking about peace on one hand, and on the other hand they are avoiding the peace treaty that is already very close to reality, if you will," Simonyan said.

Speaker Simonyan emphasized that Armenia has already drawn its red lines, such as Armenia's territory of 29,800 square kilometers.

"The red line is drawn, that not a single piece of Armenia's sovereign territory will be given up. They often speak about, for example, the four villages, but we have

thirty-one villages that are either partially or entirely under Azerbaijani occupation. Now we must talk about the thirty-one villages," Simonyan said.



### Mirzoyan, Blinken discuss Armenia-Azerbaijan normalization



Armenian Foreign Minister Ararat Mirzoyan had a meeting with US Secretary of State Antony Blinken on the sidelines of the OSCE ministerial conference in Skopje.

Issues related to security and stability in the South Caucasus were discussed. Reference was made to the latest developments in the process of normalization of relations between Armenia and Azerbaijan. Ararat Mirzoyan emphasized that despite the non-constructive attitude shown by Azerbaijan, the ethnic cleansing carried out in Nagorno-Karabakh and the existing humanitarian problems, the Republic of Armenia forwarded to Azerbaijan the proposals regarding the draft peace treaty in accordance with the well-known principles, and in case of the clear commitment of the latter, it will be possible to agree on make significant progress in this direction.

Reference was made to regional programs, in the context of which Minister Mirzoyan referred to the "Crossroads of Peace" project developed by the Armenian government, emphasizing the advantages expected as a result of its implementation.

During the meeting, the interlocutors referred to the Armenian-American bilateral agenda. Thoughts were exchanged on existing cooperation on bilateral and multilateral platforms and prospects for its expansion.

## US sees 'real opportunity' for Armenia and Azerbaijan to make peace

The US sees a real opportunity for Azerbaijan and Armenia to make peace, Assistant Secretary for European and Eurasian Affairs James O'Brien told reporters ahead of Secretary of State Antony Blinken's travel to Brussels to attend NATO Foreign Ministers meeting.

"We're encouraged that the two sides are speaking with one another directly and with mediators. And with that, we see a real opportunity for the entire region to benefit," the Assistant Secretary said.

"For example, if trade from Central Asia is able to flow through Azerbaijan and Armenia into Turkey, then it would be a substantial boost for all the countries on that trade route. And we'd welcome the opportunity to be part of that," the diplomat noted.

"At the same time, if the decision is made not to pursue that by peaceful means, then we would have to use whatever tools we could to avoid having that kind of trade route created. So we've been very clear with the parties about what we hope to see and about the consequences of moving forward otherwise. So we'll look forward to seeing where the parties

come out. We know they've expressed an interest in concluding a peace agreement very soon, and we would love to see that happen," James O'Brien said.



## Deputy Prime Minister emphasizes the EU's support in overcoming challenges caused by forced displacement of NK people

Deputy Prime Minister Tigran Khachatryan on November 28 met with the members of the Joint Delegation of the European External Action Service and the European Commission Directorates-General for Neighborhood and Enlargement Negotiations.

The head of the EU delegation in Armenia, Ambassador Vassilis Maragos also attended the meeting.

The Deputy Prime Minister underscored the significance of the delegation's visit amidst the current challenges and then presented the participants of the meeting in detail with the measures implemented by the government aimed at addressing the primary needs of forcibly displaced persons from Nagorno-Karabakh.

The Deputy Prime Minister emphasized the importance of the support of the European Union in overcoming the challenges due to the created situation, Deputy Prime Minister's Office said in a statement.

According to the source, during the meeting, reference was made to the implementation of the Armenia-EU

Comprehensive and Extended Partnership Agreement, as well as the course of cooperation in a number of directions within the framework of the EU Economic and Investment Plan. The participants also discussed opportunities for the development of Armenia-EU trade and economic relations.

It is mentioned that Deputy Prime Minister Khachatryan reiterated the government's commitment to broaden cooperation with the EU. He expressed the government's readiness to introduce new directions essential for sustainable economic development, enhance resilience, and diversify the economy, thereby enriching the bilateral agenda.





## Armenia, UK sign 2023-2024 defense cooperation plan

The 6th Armenian-British strategic defense consultations were held in London on November 28. The Armenian delegation was headed by Levon Ayvazyan, head of the Defense Policy and International Cooperation Department of the Armenian Ministry of Defense.

Varuzhan Nersesyan, Ambassador Extraordinary and Plenipotentiary of the Republic of Armenia to the United Kingdom, was also present at the consultations.

Issues related to regional and international security and bilateral cooperation in the field of defense were discussed. Levon Ayvazyan presented to his British

colleagues the security situation around Armenia and the steps taken by



the Armenian side towards regional peace and stability, including the "Crossroads of Peace" project. The large-scale reforms underway in the Armenian Armed Forces were also presented.

The parties thoroughly discussed the current course and development prospects of bilateral military cooperation. The sides noted the significant potential for cooperation in a number of new areas and the readiness to implement the agreements reached. As a result of the consultations, the Head of the Defense Policy and International Cooperation Department of the Armenian Ministry of Defense Levon Ayvazyan and the Director of the UK Ministry of Defense for Russia, Eastern Europe and Central Asia Policy David Morgan signed the 2023-2024 program of Armenian-British cooperation in the field of defense.

An agreement was reached to hold the 7th defense strategic consultations in Yerevan.

## U.S. welcomes Armenian Prime Minister Nikol Pashinyan's reforms

U.S. Assistant Secretary of State for European and Eurasian Affairs James O'Brien has praised Armenian Prime Minister Nikol Pashinyan's courage for making clear that he wants Armenia to move forward in opening its borders and in opening its relations with the West.

Speaking at an online press briefing, O'Brien noted the encouraging reforms undertaken by the Pashinyan Administration.

The U.S. official was asked to assess the prospects of supporting Armenia through the European Peace Facility mechanism and whether it may enhance Armenia's cooperation with NATO.

"I'll leave any discussion of the European Peace Facility to my EU colleagues. What I'd say is Prime Minister Pashinyan has been very courageous, has made clear



that he wants Armenia to move forward in opening its borders and in opening its relations with the West, that it doesn't want Armenia to be wholly dependent on Russia in the way that previous leaders sought to have it be. And he's undertaken a number of reforms that are - should be very encouraging for Armenian citizens as they look to continue the sort of quick economic growth that they've had over the

last year or two. And I think Prime Minister Pashinyan has also been a bold voice for a peace agreement with Azerbaijan as a way of allowing Armenia to focus on its economic development, to build out its security relationships, and to expand trade from Central Asia through to Türkiye, and all of which is something we would very much like to see. So any package that is supportive of Armenia is something to be welcomed; exactly how the EU chooses to get there will be its business. But we are committed to working with our European partners and with the government in Armenia to see that the people of Armenia are able to benefit from the reform policies that the Pashinyan government has undertaken," O'Brien said.

## Ambassador Mkrtchyan urges to realize Karabakh displaced population's right of repatriation

Tigran Mkrtchyan, Ambassador Extraordinary and Plenipotentiary of the Republic of Armenia to Greece, on November 28 held a meeting with deputy of the ruling "New Democracy" party of Greece, chairperson of the Greek Parliament's Standing Committee of National Defense and Foreign Affairs Dora Bakoyannis.

During the meeting, Ambassador Mkrtchyan addressed the security issues of the region, presenting Armenia's efforts aimed at establishing stable peace in the

region, including the "Crossroads of Peace" initiative, the Armenian Embassy in Greece informs on its Facebook page.

The ambassador emphasized the urgency of preserving the Armenian Christian cultural heritage in Nagorno-Karabakh, as well as the need to implement the right of return for forcibly displaced Artsakh citizens under international guarantees.

## I am impressed to see high growth rates in 2023 in Armenia – ADB **President**

The Asian Development Bank (ADB) forecasts 2,6% average annual inflation for 2023 in Armenia, which is quite low compared to 2022 when inflation reached 8.6%, Masatsugu Asakawa, the President of the Asian Development Bank (ADB), said in an interview with Armenpress.

In terms of Armenia's economic indicators, one of the key factors contributing to this success is the implementation of structural re-

forms, Masatsugu Asakawa said. The ADB President arrived to Armenia on a two-day visit on November 27.

First of all, I would like to ask You to present the purpose of Your visit to Armenia, what meetings and new agreements are expected?

Our visit to Armenia is multifaceted and has a comprehensive agenda. We aim to strengthen our collaboration and support for ongoing projects in the country, explore new partnership opportunities, and meet high-level officials.

During our visit, we have had the privilege to meet esteemed leaders, including the Prime Minister and the President of Armenia. One of the most significant highlights is the loan signing for the Yerevan Urban Development Investment Project, or YUDIP, which will construct a 1.8 km road and bridge over the Hrazdan River. This will greatly improve connectivity, reduce traffic congestion, and enhance green spaces for people living in Yerevan.

YUDIP is aligned with Armenia's climate goals and the Paris Agreement, and we're excited about the prospects for this and other ongoing ADB projects to improve connectivity, boost productivity, and ultimately reduce poverty. We look forward to working together to ensure smooth implementation.

Development Bank currently implementing in Armenia and how much financial support has it provided to the government and the country?

Since Armenia joined the ADB in 2005, the bank has supported the country to diversify its economy and increase opportunities for all Armenians to benefit from economic growth.

Since the beginning of our partnership, ADB has provided financial assistance worth more than \$1.8 billion, supporting government priorities in the transport, energy, water, and urban infrastructure sectors.

ADB is currently implementing six projects with the government totaling \$525 million in transport and urban infrastructure development. These initiatives are helping land-locked Armenia improve its regional and international connectivity to boost growth and development. Under the new country partnership strategy, ADB will continue supporting Armenia's regional cooperation and integration.

Our private sector portfolio comprises six projects totaling more than \$230 million in the energy, finance, and agriculture sectors. Going forward, ADB will continue to expand its private sector operations and maximize the synergies between sovereign and private sector operations.

What are the forecasts of the Asian

Development Bank for the economic growth and inflation of Armenia for 2023, how does the Bank assess the economic situation in Armenia in general? What factors greatly influenced that prediction? What are the predictions for 2024?

I commend the government for achieving impressive economic growth in 2022, despite facing various global and regional challenges. I am also impressed to see high growth

rates in 2023. Our latest forecast for this year's growth is 7%, which I believe is in line with the government's target.

In terms of average annual inflation, our forecast for this year is 2.6%, which is quite low compared to 2022 when inflation reached 8.6%. This reduction is partly due to proactive monetary policy being implemented by the Central Bank of Armenia.

One of the key factors contributing to this success is the implementation of structural reforms. The government has an ambitious reform agenda in several areas, including public administration, governance, anti-corruption, public financial management, tax administration, and digitalization.

Private sector development and domestic resource mobilization are also critical for economic growth and job creation. I am happy to note that the government continues to prioritize investments in infrastructure development - which is crucial for sustaining growth over the long term and ensuring that this growth is more inclusive.

As ADB and the Government of Armenia are working together on the new **Country Partnership Strategy for the** country, how will the new CPS support the government's de-

velopment priorities?

We are currently finalizing our new Country Partnership Strategy (CPS) for 2024–2028, which we plan to submit to ADB's Board of Directors in January 2024. The CPS is in line with Armenia's long-term strategy and the government's program for 2021–2026.

Through the CPS, we aim to help Armenia strengthen private sector-led growth with the ultimate goals of reducing poverty and inequalities and improving connectivity and productivity. These will be achieved by creating job opportunities, improving governance, and enhancing the effectiveness of reforms. ADB will continue supporting the government's efforts to promote gender equality and

gender-inclusive growth by improving the enabling environment and capacity of women. We also aim to help improve the quality of education and healthcare, and address climate and disaster risks.

What new projects is the Asian Development Bank preparing to implement in Armenia, in which areas, and at what cost?

ADB recently approved an additional financing of \$72.3 million for the Seismic Safety Improvement Program which supports the seismic safety and resilience of 46 schools in Armenia. The program is crucial to the country's School Strengthening and Renovation Program and National Strategy for Disaster Risk Reduction. This support is testament to the government's and ADB's commitment to securing a safe and resilient future for Armenia's children.

As Asia and the Pacific's climate bank, we are also helping Armenia mitigate and adapt to climate change. Today, I joined senior government members at the launch event of a new ADB report that explores opportunities for Armenia to incorporate climate adaptation into its fiscal planning. We're also preparing a proposal to help improve food security for vulnerable communities by providing them with climate-sensitive energy solutions which will help to reduce their dependence on the national grid. Through technical assistance, we are helping Armenia build the institutional knowledge needed to meet its Nationally Determined Contributions under the Paris Agreement.

ADB actively collaborates with counterparts in Armenia to invest in sustainable infrastructure, advance the digital agenda, address fiscal needs, and foster private sector partnerships. This underscores the potential for remarkable growth in this nation and the promise of our partnership.

## First Armenian indigenous satellite already in orbit

The first Armenian indigenous satellite – Hayasat 1 – developed by Bazoomq space research lab jointly with CSIE - Center for Scientific Innovation and Education, has detached from the SpaceX Falcon-9 rocket and has entered orbit.

"Next the satellite will deploy its antennas and we will establish contact with it. At this moment the satellite is charging its



batteries through solar panels," Bazoomq

Co-founder, board member & CTO Hayk Martirosyan told Armenpress.

The satellite will then start to send status updates.

The ground station can already receive data from the satellite.

The SpaceX Falcon-9 rocket carrying Hayasat-1 took off into orbit on December 1.


## Armenia, UAE sign Memorandum of Understanding "On Cooperation in the Field of Cybersecurity"

The Science and Business Days 2023 conference has brought together entrepreneurs, scientists, analysts and businessmen in Yerevan to identify the ways that science and business can jointly contribute to the development of a knowledge-based, rapidly growing economy.

Minister of Economy Vahan Kerobyan opened the forum on December 1.

Essayist, mathematical

statistician, former option trader and risk analyst Nassim Taleb is the keynote speaker of the forum.

Nobel Prize laureate, molecular biologist and neuroscientist Ardem Patapoutian, who was the 2022 keynote speaker, greeted the participants of this year's event via videocall.

The Minister of Education, Science, Culture and Sport Zhanna Andreasyan also



attended the opening ceremony.

In her speech, Andreasyan highlighted that the government has increased science funding over 150% in the recent years, and the results are already visible.

"We live in difficult times. Difficult times are times of the mind, and the mind can be developed only if we make steady efforts in the direction of developing science. This is among our government's priorities. In the past years we increased science funding over 150% and this has already given results," Andreasyan said.

Economy Minister Vahan Kerobyan recalled that the Armenian government has recently approved a support program for production of economically complex products. In the event of investments, the Armenian government is ready to return up to 35% of the investments to the

companies in the form of cashbacks and tax privileges.

The economic policy is aimed at securing economic growth based on investments and increase of productivity.

Physicist, author, and entrepreneur César Hidalgo, whose research includes the introduction of methods to measure Economic Complexity and Relatedness, also participates in the forum.

### Amazon willing to develop cooperation with Armenia

Prime Minister Nikol Pashinyan received Franco Spiciarelli, head of public policy for regional countries of the Amazon Web Services.

The Prime Minister highlighted the importance of the cooperation with the Amazon company and noted that the development of the technological sector is of primary importance for the Armenian government. Nikol Pashinyan added that interaction and active dialogue with

Amazon will contribute to the implementation of joint projects.

Franco Spiciarelli emphasized the readiness to develop cooperation with Armenia and added that they are in active discussions with the Ministry of High-tech Industry.

In particular, during the meeting, reference was made to the implementation of programs in the field of digitization and the future joint works planned in this

direction.



### AI Supercomputing Center to be established in Armenia

AI Supercomputing Center will be established in Armenia, Deputy Speaker of Parliament Hakob Arshakyan informs.

The total budget for the project is around \$8,5M. Based on the latest technologies, it will be the first in the region, the Deputy Speaker says.

According to him, the program is the implementation of the priority recorded during the meeting of the PM Nikol Pashinyan and the Founder and CEO of NVIDIA Jensen Huang that took place months ago in Yereyan.

"As the Deputy Speaker of the National

Assembly, I proposed to adopt the program of the Artificial Intelligence Supercomputing Center in the 2024 budget, which has been approved by the Government, and will soon be discussed in the National\_Assembly," Arshakyan said in a Facebook post.







## UN yet to meet its obligations vis-à-vis the people of Nagorno-Karabakh, Armenian Ambassador says

The United Nations, its respective bodies and structures have yet to meet their obligations vis-à-vis the people of Nagorno-Karabakh, Armenia's Permanent Representative to the UN Mher Margaryan said at the Side Event to the 75th Anniversary of the Genocide Convention, entitled "The Role of Religious Communities in Upholding and Implementing the Genocide."

"The International Day of Commemoration and Dignity of the Victims of Genocide and of the Prevention of this Crime, which was established upon Armenia's initiative, has evolved into a platform of dialogue and cooperation to foster prevention of atrocity crimes," Mher Margaryan said.

"The United Nations Office on Genocide Prevention and the Responsibility to Protect has a key role to play in advancing international efforts and prevention mechanisms through effective monitoring of grave human rights violations and assessing the risks of potential atrocities," he added.

The Ambassador stressed that it is imperative to reflect and address the situations when violations are committed by perpetrators that are members of the United Nations.



"Just recently, on 19 September, largescale offensive against Nagorno-Karabakh took lives of hundreds of people, including children, and resulted in mass forced displacement of the entire population. It was preceded by humanitarian crisis that the people of Nagorno-Karabakh had been undergoing since the blockade of the Lachin Corridor in December 2022, an action that has been identified by the first Prosecutor of International Criminal Court Luis Moreno Ocampo as "the archetype of genocide through the imposition of conditions of life designed to bring about a group's destruction"," Mher Margaryan noted.

"The premeditated and well-planned aggression against a population under blockade, which drove the entire

population into forced displacement, is an explicit case of an ethnic cleansing, perpetrated under the UN's watch. The entire ethnic Armenian population were driven out of their ancestral land, leaving behind their homes, their schools, their churches, their places of worship, the graveyards of their loved ones, thousands of monuments and artefacts of the vast Armenian cultural and religious heritage," he said.

"We appreciate that on 22 September 2023 the Special Advisor of the UN Secretary-General on the Prevention of Genocide issued a statement stressing that "Military action can only contribute to escalate what is already a tense situation and to put the civilian population in the area at risk of violence, including risk of genocide and related atrocity crimes"," the Ambassador said.

"The international community can no longer look the other way when faced with the clearly detectable signs of genocide, when grave and systematic human rights violations are routinely perpetrated. The United Nations, its respective bodies and structures have yet to meet their obligations vis-à-vis the people of Nagorno-Karabakh," Mher Margaryan concluded.

## UN Special Rapporteur expresses concern over destruction and appropriation of Armenian historic and religious sites by Azerbaijan

In the communication addressed to Azerbaijan, the UN Special Rapporteur on cultural rights Alexandra Xanthaki has expressed concern on "ongoing pattern of destruction and appropriation of Armenian historically, culturally and religiously significant sites and objects of religious, historical and cultural importance.

She expressed particular concern over the "allegations that the combined attacks to people, monuments and symbols, the falsification of the historical narrative and erasure of place names and

the negative discourses about Armenians may amount to cultural cleansing and will have a profound negative impact on the possibilities to restore lasting peace in the region."

UN Special Rapporteur underlined that "the International Court of Justice, the European Parliament and the Council of Europe have allexpressed concerns about a developing narrative in Azerbaijan promoting a 'Caucasian Albanian' heritage to replace 'Armenian' cultural heritage and the revisionist tendency negating Armenian cultural heritage and presence.

"The vast majority of experts in the region's art, architecture, and archaeology have all rejected the revisionist claims as false," she said.



## Genuine engagement of Azerbaijan is necessary for peace in the South Caucasus, says Foreign Minister Mirzoyan



Armenian Foreign Minister Ararat Mirzoyan made a speech at the 30th OSCE Ministerial Council, stating that Armenia remains committed to the opening of a new era of peace in the South Caucasus and believes that it is still possible. Making that opportunity a reality requires both Azerbaijan's genuine engagement and international actors' strong support for Armenia's efforts, which are based on well-developed and well-known principles.

In his speech the Foreign Minister thanked the North-Macedonian OSCE Chairmanship for leading this organization during the last year, the foreign ministry said.

"Indeed, it was not an easy task, as the OSCE which still remains the biggest security organization in the world, is rapidly declining as once duly adopted and well elaborated mandates and commitments are totally disregarded.

This process started several years ago when the OSCE failed to implement its core tasks - early warning and conflict prevention. Unfortunately, this process will continue unless there is no common understanding that violation of international law in any part of the world shall be unequivocally condemned and not tolerated, otherwise it creates a sense of impunity becoming the new normal in other parts of the world. Regrettably, the OSCE area of responsibility is not an exclusion, "noted Ararat Mirzoyan.

The Foreign Minister noted that in the South Caucasus the Nagorno-Karabakh conflict, the root causes of which was hatred and xenophobia in its various forms and the existential threat to the people who wanted to live in freedom and dignity in their ancestral homeland, reached its final stage this year.

"After a nine-month long inhuman siege, on September 19 Azerbaijan launched yet another large-scale military offensive against the people of Nagorno-Karabakh which resulted in mass forced displacement of its indigenous population. At this point in time, we can state that in silent agreement of the international community Azerbaijan has reached its long-standing goal – to get the territory of Nagorno-Karabakh without its Armenian population.

However, even after having this done the claims of the Azerbaijani side were not halted. Now the entire sovereign territory of the Republic of Armenia has become the target of our neighbor.

This, coupled with continuous hatred, military rhetoric, use of force and threats of use of force, refusal to come to the meetings organized by various international actors, including the US and the EU, illustrates that this country is not sincerely interested in peace and stability in our region," said FM Mirzoyan and added: "Despite this humanitarian disaster in Nagorno-Karabakh, Armenia remains committed to opening a new era of peace in the South Caucasus and believes that it is still possible. For turning this possibility into a reality, we need reciprocally genuine engagement of Azerbaijan and the strong support of international actors to our efforts, which are based on well elaborated and well-known principles. These principles that were widely discussed and admitted or at least not rejected by the Azerbaijani side include:

- mutual recognition of territorial integrity based on the 1991 Alma-Ata Declaration and without any further ambiguity,
- delimitation of the state border between Armenia and Azerbaijan based on the freshest and legitimate maps - USSR General Staff maps of 1974-1978,
- opening of all transport and economic communications with full respect of the countries' sovereignty and jurisdiction, as well as based on the principles of equality and reciprocity.

He reaffirmed the commitment of

the Armenian side to the above-mentioned principles, which demonstrating its readiness to embark upon practical steps, has recently presented the concept of a connectivity project which we called "Crossroads of Peace".

"This ambitious project is aimed at connecting East with West and North with South and through regional cooperation create conditions for strengthening economic and cultural ties, soften contradictions and foster better connectivity and political dialogue between the countries of our region.

In this regard the opening of the Armenia-Turkey border is also of crucial importance. As you might be aware, we have reached the agreement to open the land border for 3rd country citizens and Armenian and Turkish citizens holding diplomatic passports, which was reconfirmed by my counterpart, Minister Fidan at our bilateral meeting on October 23; even concrete timing was indicated meaning upcoming weeks, and we hope that in the nearest future we will implement this first, but quite tangible step.

There are also a number of humanitarian issues on Armenia-Azerbaijan normalization that cannot be ignored. The release of all Armenian detainees, including the ones imprisoned after September 19, cooperation in addressing the fate of missing persons, protection of Armenian cultural property in and around Nagorno-Karabakh can pave a way to long-lasting, just and dignified peace," Foreign Minister said.

In conclusion, FM Mirzoyan noted that Armenia as a responsible member of OSCE has proved on numerous occasions its devotion to regional and global peace and will continue to take steps to that end.

"And once again, I reiterate that Armenia remains ready for negotiations and we need Azerbaijan to stop rejecting the proposals of facilitators to meet and finalize the peace treaty. To ensure this goal we need genuine efforts of all interested parties and the international community as a whole to turn the page of violence in the South Caucasus and strengthen international rule-based order," concluded Foreign Minister Mirzoyan.







## Center for Excellence in Journalism to be established in Armenia with U.S. Support



The American University of Armenia (AUA), in partnership with Washington State University (WSU), on November 30 signed a memorandum of understanding (MOU) to establish a Center for Excellence in Journalism and create a new Master's program in journalism education.

The \$1.3 million, four year university partnership initiative is funded by the U.S. Embassy in Yerevan to support Armenia's media sector, the U.S. Embassy in Yerevan said.

According to the source, through the U.S. Embassy's support, 90% tuition scholarship will be provided to approximately nine graduate students per year to study in the Master's in Journalism degree program, with a select number of students also having the opportunity to compete for a summer internship in the United States, where they will earn hands on reporting skills in a U.S. media outlet.

U.S. Ambassador to Armenian Kristina Kvien as well as Minister for Education. Science, Culture and Sport Zhanna Andreasyan, also attended the launch event.

"This U.S.-Armenia relationship is based on shared values, including press freedom and the critical role of education in building a strong, democratic society that is resilient to disinformation," said Deputy Assistant Secretary Mansour at the inauguration event. "The United States is proud to invest in this university partnership initiative, which will support Armenia's democratic development, and invest in the next generation of journalists."

"This project aims to support current and future journalists with the knowledge and skills to have a positive impact on the journalism sector in Armenia and beyond," says Dr. Yacoubian, Dean of the College of Humanities and Social Sciences(CHSS). "The project will contribute to further diversifying the academic portfolio of CHSS and thus providing new possibilities for us as we prepare students to become civic and professional leaders.
